But the Annual Report released this month by The Greenville County Museum of Art presents a circumspective accounting of the year 1970-71 that reveals a sensitive awareness of the directions of change, definitive visions for the future, specific proposals for the attainment of goals and enumerative actions that are in the process of bringing about these goals.

The report, on file in the Museum Art Reference Library, and available on request to members of the Art Association and other interested persons renders the following statistical data of the past five years; it is indicative of awesome potential growth in the future:

Incorporated within the body of the report are revealing statements by Museum officials that underscore a sensitivity to responsible planning for future generations of Greenville County citizens and the concurrent actions of the Museum as a public institution to keep abreast of and generate cultural advances:

-From the President, Greenville County Art Association:
"The Board of the Greenville County Art Association has lived almost entirely in the future tense, anticipating the appropriate of our power presume.

"The generosity of Mr. and Mrs. Arthur Magill and the foresight of the Greenville County Council, coupled with the vision and efforts of many other community organizations and individuals has culminated in a new era for the Art Association and the Greenville County Museum. DESIGNER-CRAFTSMAN EXHIBITION

The first designer-craftsman exhibition sponsored by the Greenville Artist Guild will include works in ceramics, macrame, stitchery, weaving, jewelry, enamelings, glass and other related media.

All members of the Guild were encouraged to submit up to five works. Selection will be determined from among the sixty pieces submitted for juror Tom Turner, teacher at Clemson University and one of the outstanding craftsmen of our day.

Special awards will be presented during the opening preview reception to be held for Guild and Art Association members Sunday, February 6 at 3:00 p.m.

The Greenville County Museum of Art and the Museum School of Art are owned and governed by the Greenville County Delegation through the Museum Commission. Founders and members of the Greenville County Art Association have contributed the Museum buildings, grounds and art collections. Membership fees and contributions provide the balance to county support and enable activities, services and growth.

Membership in the Greenville County Art Association, a vital extension of the Museum, is open to all and offers numerous advantages and opportunities including discounts at the Museum sales desk and Art School registration, the film and concert series, special invitations and announcements, etc. Complete information is available through the Museum - 233-0497.

Museum School of Art . . . 27 weekly courses for youth and adult are conducted in a workshop atmosphere under the professional guidance of 16 qualified instructors. Sessions are held each fall, spring and summer. For complete information request a school brochure - 233-1259.

Education . . . The Museum conducts art education programs designed for specific age groups. Trained guides are available for school classes and other groups to supplement and enhance the knowledge gained through the collection and special exhibitions. Tours, films or slide lectures should be arranged with the Curator of Education at the Museum at least two weeks in advance.

The Education office also maintains an art reference library containing books, films, current periodicals and publications and is available for use during weekday Museum hours and Sunday afternoons.

New programs presently serve over 40,000 school students with an excellent and continually growing program of art orientation through an artmobile, suitcase exhibits, visiting lecturers, and programs correlated with the gallery exhibi-
